ART. 1_ OBJECT OF THE SCIENTIFIC COMPETITION NAMED “PIRANESI PRIX DE ROME ET D’ATHÈNES – 2020. INTERNATIONAL CALL FOR PROJECTS FOR THE ACROPOLIS OF ATHENS ”

The Accademia Adrianea di Architettura e Archeologia announces the INTERNATIONAL CALL FOR PROJECTS FOR THE ACROPOLIS OF ATHENS. In particular:

- Redevelopment of the Acropolis *Plateau*;
- Redevelopment of the North and Southwest slopes of the *Peripatos*
- Physical and perceptive connections between the Rock and other sensitive areas within the perimeter of the UNESCO Buffer Zone (Areopagus, Pnyx, Philopappus, Ancient Agorà).

The Call is part of the XVIII Edition of Piranesi_Prix de Rome 2020 and is closely connected with the International Conference “**PIRANESI PRIX DE ROME ET D’ATHÈNES – 2020. PROJECTS FOR THE ACROPOLIS OF ATHENS**” to be held in Rome on 28th August 2020, during which the project proposals will be presented.

ART. 2_ OBJECTIVES OF THE INTERNATIONAL CALL

The International Call for the Acropolis of Athens is a scientific consultation whose main objective is the elaboration of a series of project proposals aimed at the redevelopment and rearrangement of the main monumental, archaeological and landscape emergencies within the perimeter of the UNESCO Buffer Zone inside the Central Area of Athens. This also intends to consider the relationship between the archaeological site and the new needs generated by the contemporary forms of a globalized cultural tourism, meant as the offer of services based on real urgencies and strategic connections with the city, in a framework of shared sustainability of the redevelopment interventions.

Given the main scientific objective, they are subtended:

- 1) **The assignment of the Piranesi Prix de Rome et d’Athènes – 2020** to the project proposals that have best interpreted the role and identity of the archaeological site of the Acropolis – in particular the relationship between archaeological and landscape surroundings, *Peripatos* and *Plateau* – and that have proposed suitable solutions to the needs of accessibility and visit, understanding and comfort of the site, both in terms of services to visitors and strategic connections – at the level of routes and panoramic/pan-optical points of view – with the sensitive areas of the Buffer Zone.
- 2) **The analysis and understanding of the state of the art** in architectural design for cultural heritage sites, by way of a competitive project based on international event with scientific and artistic implications, focused on one of the most important archeological area in the world.

- 3) **To organize an international conference** as per the Art. 1, dedicated to the presentation of selected projects by their authors. These presentations are part of the competition process.
- 4) **To build an exhibit of the selected projects** concurrent with the XVIII Edition of Piranesi_Prix de Rome 2020 activities, or alternatively, on other dates and in other places to be defined.
- 5) **To publish an academic-scientific text**, that will be a methodological reference for institutions and designers engaged in cultural heritage.

ART. 3_TARGET OF THE INTERNATIONAL CALL

The International Call is reserved for university architects-professors belonging to a School of Architecture or University Department of Architecture (Italian or from other countries) – in interdisciplinary scientific collaboration with archaeologists and art historians and their Departments – and, possibly, in partnership with architectural design firms of international profile (Italian or from other countries) who have developed stable relationships with the University. These participants will then form university participation groups.

More in detail, the university group must:

- be member of an **Architectural School or Department** or a **Doctoral School**;
- be **guided by one or more designers** (with skills in architectural and urban planning, landscape, architectural and archaeological restoration, in drawing and museographic disciplines). It is also suggested the involvement of an archaeologist, an art or architecture historian (with competence in Greek-Roman classical antiquity) and agronomists, as consultants who can also be identified outside the School of Architecture or the reference Department.
- possess a **curriculum** in which there are scientific titles and specific publications concerning the themes of the architectural project for cultural heritage, as well as completed design experiences in the same field, which qualify the profile even under the best practice. Considering that this curriculum consists of all titles presented in the various curricula of the members of the group, the qualifications must bear the reference to the single author, or to the authors in case they are related to group work.

Regarding the **composition of the university group**:

- As "university professor", we mean a figure of a designer architect, whether a full professor or associate professor (full-time or definite), or a professor emeritus, full-time researcher (including

- RTDA and RTDB according to Italian legislation), or, finally, a contract (adjunct) professor who can demonstrate continuity in teaching assignments (at least five years, even if not consecutive) with respect to the areas mentioned above – preferably with the university of reference – which can play the role of coordinator of the group;
- It is possible to form groups, if considered appropriate, which are also conducted by more coordinators up to a maximum of three and referred to the three project scales (scale of landscape, scale of architecture and scale of museography). In the group can also be involved grant holders, students of the Doctoral Schools belonging to the same School and students who are recognized as University Credits;
 - If the university group has only one coordinator, it must be an architect. If the group has two or three coordinators, one of these may be archaeologist or historian of the art or architecture;
 - University groups attached to a Doctoral School may participate under the guidance of the Coordinator of the Doctoral Course of disciplinary interest or other coordinators identified among the structured professors that are officially part of the College of teachers of the same doctoral course. Interdisciplinary involvement with other Doctoral Schools is possible.
 - It is possible the participation of several groups belonging to the same School of Architecture (or Department);
 - In case of involvement of an external architecture firm in partnership, this must be of international profile and possess a curriculum in which it is possible to deduce the university teaching experience, the continuous participation in competitions at international level in which at least figures the attribution of a prize or other recognition attesting the commitment and the search for quality in architectural design for culture and heritage.

Furthermore, in the **curriculum of the university group** – and, possibly, in that of the professional with an international profile – at least one of the types of works required by the announcement specified in the document of the Guidelines for Design must be present.

Among these, in the evaluation of curricula will be important:

- Structures aimed at the fulfillment of services to the public (access systems, reception and hospitality) to support the use of archaeological areas;
- Museum buildings and in particular archaeological museums, archaeological exhibit displays;
- Structures and artefacts aimed at the "open-air" musealization of archaeological and excavation areas;

- Landscaping of parks, theme gardens, orchard gardens, botanical gardens;
- Reversible architectural structures, based on predominantly wooden construction systems also referable to bio architecture.

In short, the curriculum must reflect the substance and objectives of the present announcement, which favor extensive and reversible architectural interventions, an architecture of the ground framed in a green landscape partly strongly connotated and partly to be studied.

ART. 4_PARTECIPATION

To participate to the International Call it's necessary the drafting of a project proposal to be presented according to the indications in the following point. **The consultation is divided into two phases**, the first is characterized by the selection of a congruous number of project proposals, in compliance with the objectives n°2, n°3 and n°5 of the International Call, as better specified in the following Art. 5.

The selected design proposals will receive a NOMINATION and will be presented in a public session on Friday 28th August 2020, on the occasion of the conference "**PIRANESI PRIX DE ROME ET D'ATHÈNES – 2020. PROJECTS FOR THE ACROPOLIS OF ATHENS**" and possibly exhibited during the XVIII Edition of Piranesi_Prix de Rome 2020, or subsequently in other locations.

A requirement of participation at the call and thus the XVIII Edition of Piranesi Prix de Rome 2020 is the presentation of the project at the conference which the groups are asked to attend. The presentation must be held directly by the group coordinator, or alternatively, by a specifically qualified person.

Participation in this International Call must be preceded by the submission of the **APPLICATION FORM** to be downloaded from the website www.accademiaadrianea.net (procedure open from **MARCH 1st 2020**). The application form must be attached **duly completed and signed** at the bottom of the appropriate form attached to the announcement (ANNEX B), **NO LATER THAN APRIL 27th 2020**.

Participation at the International Call does not include professional commissions but only scientific and artistic recognition, and does not foresee further design development.

ART. 5_INCOMPATIBILITY CONDITIONS

Kinship and affinity up to the fourth degree are not compatible with the participation in the Call, as well as the relationship of work and work dependency between competitors and members of the commissions.

ART. 6_CONFERMENT OF THE PIRANESI_PRIX DE ROME

The project proposals selected (NOMINATIONS) and presented at the Conference on 28th August 2020 in Rome, at Casa dell'Architettura – Acquario Romano, will compete for the award of the XVIII Edition of Piranesi_Prix de Rome 2020. The projects presented will be evaluated according to the methods described in the following Art. 8. The proclamation will be held in public session at the end of the Conference, (location to be defined).

ART. 7_OBJECT OF THE CALL AND CONTENTS

Object of the Call is the Acropolis of Athens, to be considered both in its role of archaeological site heritage of humanity, both as maximum attraction within a more complex system: the UNESCO Buffer Zone, composed of a large number of points of interest, monumental and landscape. The results of the consultation should therefore include proposals for the redevelopment of the archaeological site but also strategic reflections on the UNESCO Buffer Zone, with a perspective of integration and interaction between the different parts.

In this perspective, the Call intends to be an opportunity to focus on some topics and issues currently existing on the Acropolis and to constitute a block of proposals useful for their interpretation and accommodation. In the same way, the idea of broadening the gaze towards the UNESCO Buffer Zone – without remaining focused onto the perimeter of the fortifications of the Sacred Rock – wants to be an innovative interpretation of the site, in partial continuity with some interventions of the past century (such as the paths of Dimitris Pikionis) and the XIX century (Perserschutt).

The consultation, in its nature of scientific prize based on a competition for ideas and projects, asks the Italian and foreign universities, in particular those operating in contexts characterized by the presence of UNESCO sites, to propose their own interpretation about the ways and possibilities of planning on the Athenian archaeological site, characterized by both practical needs and universally recognized cultural and identity issues. The Acropolis of Athens, archaeological site *par excellence*, is here understood as a research field *for excellence* for the contemporary discipline of Architecture for Archaeology.

In detail, the project proposals are articulated in the following themes and contents.

SCOPE 1 – CONNECTIONS

Study of the strategic connections – physical and visual – between the Acropolis and its slopes in relation to the sensitive sites within the perimeter of the UNESCO Buffer Zone (Areopagus, Ancient Agorà and Pnyx). In particular:

- **Vertical connection between the Ancient Agorà and the Parthenon** on the Acropolis passing at the bottom of the Areopagus hill, by retracing and redefining the landscape and the architecture of the processional route of the Panathenaea.
- **Accessibility/exploration of the Areopagus hill.** Considering the strategic position of this large rocky spur and the visual control of every point of the Archaeological Park we can imagine a layout proposal of the routes and, of course, of the panoramic area placed on top with the project of a panoptic installation.
- **Musealization of the Pnyx hill,** upland characterized by a visually structured archaeological structure with the assembly hemicycle, the layout of the eastern defensive system and the Stoàs of Lycurgus. The site is available for a new design reflection, aimed at the realization of a museum complex, to be placed in continuity with the existing paths and in harmony with the extraordinary landscape that it offers.

SCOPE 2 – PERIPATOS

Redevelopment project of the route of the Northern side of the *Peripatos* and rearrangement of the South-West slope through interventions aimed at providing services to support the restoration and scientific divulgation activities and to support the activities relate to shows and exhibitions.

- **The route (Northern slope).** Valorization of the route and proposal for a new landscape accommodation including flooring, equipment to support the visit and new technical and aesthetic solutions for the relocation of lighting along the path of the Peripatos (even with the introduction of new generation technologies). More over the designing of a new elevation system (lift) on the Northern slope, according to the natural and monumental landscape of the Rock. It has to be meant as an updating of the existing lift, which can be a support to reach the sanctuaries and springs above the *Peripatos* route;
- **The Center for the Restoration of the Acropolis.** Accommodation by architectural intervention on the site in front of the Grotto di Aglauro, now used as a working site outside the Rock, aimed toward the equipping of new spaces for scientific communication and of laboratories for the restoration and processing of stone materials for the monuments of the Acropolis.
- **The Odeon of Pericles.** Reconstruction of the building known as Odeon of Pericles as a multifunctional space for exhibitions.

SCOPE 3 – PLATEAU

Project of redevelopment of the Acropolis *Plateau* and re-arrangement of the sites of restoration close to the *Perserschutt* and of the Old Museum:

- **Soil and paths.** Arrangement of the surface of the Acropolis and its paths, according both to the architectural and monumental composition of the Rock and to the use of the site, with attention to the greenscape;
- ***Perserschutt.*** Within the area between the Parthenon and the southeast bastion of the Acropolis, the project proposal deals with the following three concatenated topics:
 - The Old Acropolis Museum. Redevelopment and renovation of the museum building currently located in the Southeast corner of the Rock;
 - The sites of restoration. Reconfiguration of the spaces dedicated to restoration activities in the vicinity of the Parthenon (currently prefabricated box) in a new system; it is possible to think about a new use of the spaces of the Old Acropolis Museum;
 - Excavation. Hypothesis of accessibility and musealization of the area of the *Perserschutt*, to be considered in the framework of the restoration of the Old Museum and the reorganization of the sites of restoration.

Each group will have to develop a coherent project with a general idea of the site able to keep the three scopes harmoniously together and that will have to answer at least one of the design questions underlying the same scopes. In the end, each group will be free to decide which project theme develop among the three foreseen in the **Scope 1– Connections** (the Panathenaic Way, the Belvedere of the Areopagus or the Museum of the Pnyx) and between the three foreseen in the **Scope 2 – Peripatos** (the redevelopment of the route, the Centre for the Restoration of the Acropolis or the Reconstruction of the Odeon of Pericles). For what concerns the **Scope 3 – Plateau**, the theme is unique: the redevelopment of the extrados of the Rock of the Acropolis with the insights on the arrangement of the *Perserschutt*/Old Museum and the Acropolis Gardens.

The project themes will be explained in detail in the **Preliminary Document to the Design**, attached to this call, to be requested from the secretariat of the Piranesi_Prix de Rome, by sending the Annex A.

ART. 8_ PROJECT EVALUATION PROCESS AND JURIES

The evaluation of the proposals will take place in two phases.

The **first phase**, through the simple presentation of the curricula, has as its scope the verification of the participation requirements, the level of multidisciplinary and methodological in-depth analysis required. It will be able to achieve a possible selection of proposals, according to the method of comparative assessment, based on the principles set out below.

The **second phase** with a more specifically evaluative character, based on the design comparison, is aimed at drawing up a ranking and assigning the Piranesi Prix de Rome et d'Athènes 2020, as per Art.2, paragraph 1 of this announcement.

SELECTION COMMITTEE (FIRST PHASE)

The Selection Committee (CDS) is responsible for the formal verification of the curricular documentation sent by the university groups, in relation to the level of quality required in reference to the contents and objectives of the Call, as per Article 2 of this announcement.

The evaluation criteria will essentially concern:

- a) respect for the multidisciplinary composition of the project group and the level of involvement of the various scientific disciplinary sectors;
- b) the international level of project experiences and scientific publications attested and consistent with the themes and objectives of the Call.

The Selection Committee is formed by:

- the President of the Accademia Adrianea, Prof. Pier Federico Caliarì, as President of the selection Committee;
- the President Emeritus of the Accademia Adrianea, Prof. Romolo Martemucci;
- the Director of Piranesi_Prix de Rome, Prof. Luca Basso Peressut;
- the member appointed by the National Council of the Order of Architects, Prof. Livio Sacchi;
- the designated member of the Commission for Culture of the Casa dell'Architettura, Prof. Luca Ribichini;
- the designated member of the Scientific Committee of Piranesi_Prix de Rome, Prof. Luigi Spinelli;
- Mrs. Maria Patti, administrative director of the Accademia Adrianea as Secretary.

The CDS, based on the actual participation, and in compliance with the objectives n°2, n°3 and n°5 of the International Call, will select a congruous number of project proposals, not less than twelve projects and not more than twenty-four.

SCIENTIFIC EVALUATION COMMITTEE (SECOND PHASE)

The Scientific Committee (CSV), will be composed by five up to seven members, will have an international character and will operate in two phases:

- a) Through a blind peer review procedure (anonymous projects and anonymous commissioners) aimed at assigning scores to individual projects and drawing up a ranking of the same. This procedure will take place before the public presentation of the project that will be held during the Conference (August 28th 2020);
- b) By comparative evaluation on the short list, formed by the first twelve groups that will get the highest score in the ranking. The comparative evaluation will be open voting and will take into due consideration the quality of the presentation of the project proposals during the Conference that will take place on August 28th 2020. In fact, the CSV will be able to reconsider up to two or three applications excluded in the blind peer review and reassess the project proposals through the repechage procedure. This procedure will take place during and after the public presentation of the project that will be held during the Conference (August 28th 2020).

At the end of the comparative evaluation, six winning projects will be selected ex aequo for the scientific prize “**Piranesi Prix de Rome et d'Athènes – 2020**”.

Cannot be members of the Scientific Committee the above listed members of the Selection Committee.

The assessments of the blind peer review procedure will be carried out with remote electronical procedure; the results will be sent in real time and the data will be checked by the responsible of the procedure assisted by the President of Accademia Adrianea.

ART. 9_AWARDS

Six prizes ex equo will be assigned. To the winner groups of the International Call for the Acropolis of Athens, the “Piranesi Prix de Rome et d'Athènes – 2020” will be honoured and they will be enrolled in the Hall of Fame.

These groups will receive additional recognition, consisting of an editorial contract for the publication of their project in a monographic key (not a substitute for the publication of the Call's projects catalogue referred to in ART. 14 PROJECT PUBLICATION).

The publishing contracts establish a prize money of twenty-four thousand Euro (24,000), distributed in six editorial modules among the six winning projects ex aequo.

Each editorial module value is Euro 4,000 and refers to a publication of 112 pages (7 modules of 16 pages) entirely in colour.

All publications will be in electronic format, with ISBN code and published by the editorial brand Accademia Adrianea Edizioni in the new editorial series named "Patrimonio e Progetto" ("Heritage and Design"); they will be available directly and free of charge through the web platforms Accademia Adrianea Onlus www.premiopianesi.net and www.accademiaadrianea.net and on other platforms under request.

Upon winners' request the monographs could be reprinted at their own editing and charge with a new ISBN code – but with the same layout – referred to another editorial brand that will operate under the licence of Accademia Adrianea Edizioni, by transfer of rights and relative convention.

Publications will start in 2021 and can be scheduled by those entitled within the period 2021-2022.

ART. 10_SUBMISSION ELABORATES PHASE ONE (DEADLINE MAY 15th 2020)

ELABORATES REQUIRED FOR PHASE ONE

For the selection phase of the project proposals, in adherence to the objectives referred to in Art. 2, paragraph 1, 3 and 5, the following documentation must be sent in digital format:

- **PDF file of a layout in A3 horizontal format, called CURRICULUM**, containing the documentation relating to the university group and, possibly, to the partner design firm, if any, to testify the quality of the scientific activity, of research and designing of the group, in relation to the relationship between architecture, archaeology heritage and landscape, with specific reference to the types of intervention expressed in Art. 3, paragraph 4 of this announcement.

The layout, complete with texts and images necessary for a better understanding of the curricular quality, must consist of a maximum of ten pages plus the cover. Altogether, eleven graphic pages organized as follows:

- **Illustrated cover**, with the name of the School of Architecture (or Department) or Doctoral School + the name of the Coordinator(s) of the group, as well as the title: "PIRANESI_PRIX DE ROME ET D'ATHÈNES XVIII EDITION 2020. INTERNATIONAL CALL FOR PROJECTS FOR THE ACROPOLIS OF ATHENS. CURRICULUM";
- **First page** must report the colophon indicating the names of the entire group, including collaborators and scientific and artistic consultants, specifying the name of the Coordinator of the university group (or the names if there are more than one). Finally, an email address and a reference telephone number must be highlighted for any contact;
- **Nine pages**, with texts and images of your choice, organised as an illustrated portfolio that documents in a comprehensive manner all the skills of the university group, the architecture, landscape and museography projects realized, the research projects concluded and in progress, eventual engagement in the high formation and in the organization of conferences and seminars related to the project themes of this announcement.

The text will be exclusively in Italian or English, and typed with Arial character, body 11 and single interline. Titles in Arial body 14 bold. Subtitles in Arial body 12 bold.

ART. 11_ SUBMISSION ELABORATES PHASE TWO (DEADLINE 1st AUGUST 2020)

The groups in compliance with the provisions of this announcement, and with reference to the Second Phase of the PIRANESI PRIX DE ROME ET D'ATHÈNES – 2020 referred to in Art.2, paragraphs 1, 3 and 5, will be contacted by email **by MAY 22th 2020** and invited to produce the competition documentation for participation in the second phase.

Consequently, the groups must communicate to the Organization, by completing and sending the **ANNEX C** (to be downloaded from the site www.accademiaadrianea.net, properly filled in and uploaded at the bottom of the appropriate form):

- The acceptance of the NOMINATION and the consequent participation in the Conference and the Exhibition;
- The presence of the group Coordinator(s) at the presentation of the NOMINATION at the aforementioned conference;
- Otherwise, the indication of another qualified person for the presentation of the project proposal.

In case neither the Coordinator(s) nor any other qualified person can be present for the presentation of the project proposal, the NOMINATION will be considered automatically lapsed.

ELABORATES REQUIRED FOR THE SECOND PHASE

The selected groups, referred to in paragraph 1 of this article, who can support their NOMINATION at Piranesi Prix de Rome e d’Athènes – 2020, are invited to produce the following documentation, by sending a package containing:

- **N ° 3 tables in ISO A0 format (mm 841 x 1189 h).** Each table will be referred to the design Scopes described in the previous Art. 7 (object of the call and contents). The first table will show the Masterplan of the entire project proposal.

Table 1_Masterplan UNESCO Buffer Zone (SCOPE 1)

Composed primarily of the Masterplan of the entire project proposal, and of an insight on one of the three design themes of the Scope 1, specifically: the Panathenaic Way, the Belvedere of the Areopagus or the Musealization of Pnyx.

For what concerns the Masterplan, must be highlighted:

- a) the landscape solutions, indicating the location of new green arrangements and of the observation points;
- b) the planivolumetric solutions of the interventions adopted.

The Masterplan will also be accompanied by the main views (rendering or photo insertions) of the individual project themes, together with a short explanatory text and the captions of the images.

Table 2_Peripatos and slopes of the Acropolis (SCOPE 2)

Table composed by an in-depth study of the design choices at the architectural and landscape scale referred to one of the themes of the Scope 2:

- c) the new proposal for the accommodation of the Peripatos, including the flooring, the furnishing and the equipment to support the comfort and understanding of the visit, redevelopment of the monumental lighting system (inclusion of the arrangement and lighting proposal in the context) and also of the proposal of the updating of the elevator towards the Acropolis connected to the system of sanctuaries and springs nested in the Rock;
- d) the architectural and landscape solution for the Center of Restoration of the Acropolis (connected to the *Plateau* sites): a complex provided with an outdoor working area, reatoration laboratories with didactic classrooms, a small conference hall, offices, café, etc.
- e) the architectural and reconstructive solution of the area of the so-called *Odeon of Pericles*, aimed at reorganizing the ancient multifunctional system addressed to shows and expositions;

The solutions could be represented by plants, elevations, sections, renderings, photo intertions and diagrams.

Table 3_ *Plateau* of the Acropolis (SCOPE 3)

Table composed by an in-depth study of the design choices on the architectural and museographic scale, in which are highlighted:

- f) the proposal for the development of the *Plateau* soil, in which are represented the choices regarding the paved paths of access from the Propylaea towards the Parthenon and the Erechtheion, the greenscape, and the path along the perimeter walls of the Rock, including any steps of reconnection of the heights and themed fences also treated with garden. Set facilities and panoramic views, as well as visual communication equipment to support the understanding of the visit;
- g) the proposal to restructure/redesign the Old Acropolis Museum located in the South-East corner of the fenced walls, taking into account not only the museological-museographic aspects of the interior layout, but also the specific stratigraphic conditions buried in the so called Perserschutt: in particular, the traces of the archaic defensive circuits, the stereobate of the Parthenon and the presence – under the Old Museum – of the Sanctuary of Pandion. Special attention should therefore be paid to the possibility (downstream of an archaeological excavation) to make accessible and visitable the complex of pre-existences,

- that are of great importance for the reading and understanding of the Acropolis in its transition between the VI and the V century B.C.;
- h) the reconfiguration proposal of the site area to support the work-in-progress related to the Parthenon, through a solution drawn in harmony with the image and the importance of the site, stable over time but technologically reversible. This hypothesis must be aligned with what is required in points f) and g) with the objective of completely reformulating the relationship between visiting and restoration, by reconciling the development needs of the reconstruction activities with those of the experience of the visit.
 - i) the proposal relative to the study of the redefinition of the Acropolis Gardens, to be meant as the introduction of a soft and sustainable intervention within the general aim of the Call; the topic of the “new soil” of the Acropolis can be harmoniously combined to the one of the “new green”.

The design solutions could be represented by plans, elevations, sections, renderings, photo insertions and diagrams.

The design solutions expressed in each table must be accompanied by two abstracts in Italian and English.

Tables printed on paper and subsequently fixed on a rigid support are not allowed, under penalty of exclusion. In the event that the participants do not have suppliers equipped in such sense, the service can be carried out by sending the files to specialized websites, of which the Organization will be able to provide the links.

The images will have to be of absolute digital quality for an excellent resolution.

The tables will be edited following the template in ANNEX D (available from May 31st 2020, directly on the web page of the Accademia Adrianea dedicated to the download).
